Hello Alyson and Chief Lee,

I received the following [disturbing] tip and I am hoping you can let me know whether it [or any parts of it] are true and if so if there are any written reports associated with the incident[s] please provide copies.

**The Tip:
Where: HOB School**

What:

- 1. Within past two months: An 8th grader [last name XXXXX] was accused [by multiple other other students] of having brought a gun to school and having shown the gun to some students. Those students told school authorities including the KWPD resource officer.**
- 2. Thereafter, not sure when: The same student [XXXXX] sent a snapchat to a student showing himself [XXXXX] pointing a gun and threatening to kill the student to whom the snapchat was sent ['I'm going to blow you away.']. There is a screengrab of that snapchat image showing XXXXX with the gun.**
- 3. A few days ago: The same student [XXXXX] verbally threatened to kill another student. 'The next time there is an after-school event I'm going to kill you.' [My source is paraphrasing what was said.]**
