On February 4, 2017, I was dispatched to Publix located at 2900 North Roosevelt Boulevard, in reference to a white male who was sleeping outside of the store. The manager stated that the subject was there the previous night and had returned.

Ofc. Gomez arrived before me and made contact with the white male, identified as Kristopher Knight. Ofc. Gomez explained to him that he was disrupting the business and at the request of Publix and Key Plaza he was being issued a trespass warning for the entire Key Plaza property. Key Plaza Land Trust, the owner operator of the property has authorized the Key West Police department to remove trespassers and loiterers from the property and they will prosecute to the fullest extent of the law. Knight became agitated and was refusing to leave the property. Ofc. Gomez and I gave Knight multiple opportunities to leave the property and he slowly got up to leave the property after he was told he would be arrested if he did not leave.

Knight got up and was walking away, however, as he walked in front of the doors to Publix, Knight started yelling and cursing in front of customers which included families and children. Due to Knight's disruptive behavior and reluctance to leave the property, I decided to arrest him for trespassing. I walked up behind Knight and told him to stop and he was under arrest. Knight continued to walk away and I told him to stop again. Knight refused to stop and to walk away from me. I grabbed onto Knight's right shoulder to stop him and he pulled away from me. Knight continued to pull away from me and I pushed him into several trash cans that were next to the wall. Knight fell to the ground and I handcuffed him. I stood Knight up and walked him back to my marked patrol car. Knight continued to tense his body and pull away. I used a wrist lock to keep physical control of him while we walked back to my marked patrol car. I placed Knight against the rear of my marked patrol car and instructed him to move his feet apart so I could search his person for weapons and contraband. Knight refused to comply with my lawful orders. I continued to use a wrist lock to maintain compliance. Knight did comply and I was able to search his person for weapons and contraband without incident. I placed Knight into the rear of my marked patrol car. I told Knight to turn his head away from me while I fastened his seat belt. Knight again refused to comply with my lawful order. I pushed my forearm against the right side of Knight's head and turned his head to prevent him from biting me or spitting on me while I fastened his seatbelt.

Once in the rear of my marked patrol car, Knight continued to yell and scream. Knight then banged his head against the right rear window of my marked patrol car. Knight then started banging his head against the Plexiglass partition. Ofc. Gomez and I told him to stop hitting his head on the window and partition as he would only hurt himself and not the window. Knight then started spitting on the right rear window of my marked patrol car. Next Knight started kicking the right rear window of my marked patrol car. To prevent Knight from breaking the window and possibly injuring himself, I opened the right rear door of my marked patrol car and pushed Knight's body against the seat. I placed my knee across Knight's legs to prevent him from kicking. Ofc. Gomez got a hobble out of my marked patrol car. Due to Knight kicking and his previous resistance, I removed him from the rear of my marked patrol car and moved him to the sidewalk area. I gave Knight loud verbal commands to get onto the ground and pull his feet out from under his body. Again Knight refused to comply with my lawful commands. Ofc. Gomez and I were able to pull Knight's legs from under his body. Knight continued to twist his body to hinder our efforts to execute our lawful duty. I placed my knee on Knight's shoulder blade to pin him to the ground and I used a wrist lock to gain compliance. Ofc. Gomez applied the hobble to Knight's ankles. While Ofc. Gomez was placing the hobble

on Knight, he began screaming and yelling. Due to Knight's screaming a group of people recording this incident formed around Ofc. Gomez and I. Ofc. Gomez and I got knight to his feet and placed him into the rear of my marked patrol car.

A supervisor was requested to respond to the scene because I had to use force to respond to Knight's resistance. I left the scene prior to a supervisor arriving due to knights actions in the rear of my marked patrol car and the crowd that was gathering at the scene. I transported Knight to MCDC without further incident.

Once we arrived at MCDC Ofc. Malgrat photographed Knight to document his condition. Knight did not have any visible injuries or complain of any injuries from this incident. The medical staff at MCDC request Knight go to the hospital for medical clearance due to a blood pressure issue. KWFD Rescue responded to MCDC and transported Knight to Lower Keys Medical Center for further evaluation. We arrived and the staff at Lower Keys Medical Center evaluated Knight. Knight was medically cleared to return to MCDC. I transported Knight back to MCDC for processing without incident.
