[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

On 11/19/2013 I responded to the Lower Keys Medical Center(ER) reference to a disorderly conduct patient. Upon my arrival I saw a person by the name of Amado Canbera, who's known to this officer for the past few years, Cabrera was yelling screaming from one of the ER rooms and was belligerent towards the medical staff. Amado Cabrera was medically Cleared and release from the Hospital. Cabrera was pending charges from Special Opps.

As I was placing Cabrera on the back seat of my patrol vehicle, as I was attempting to place the seat belt on Cabrera, He Cabrera intentionally spit on my left side of my face into my left eye. I placed my left hand over Cabrera's mouth to keep him from spiting on me again, after he was secured with the seat belt I went inside the ER to wash my face with soap and water. The Dr. at the ER placed a Spit mask on Cabrera to keep him from spiting. Cabrera was transported to the Jail with no further incident.
